- Standards Compliance: Our website aims to conform to the Web Content Accessibility Guidelines (WCAG) 2.2 Level AA, as set by the World Wide Web Consortium (W3C) Web Accessibility Initiative (WAI).
- Compatibility: The CLEAN Helpdesk is designed to be compatible with assistive technologies and the latest versions of major browsers, including Chrome, Firefox, Safari, and Edge. Note that it may not display optimally in Internet Explorer or older browsers.

### **Policies and Plans**

- Accessibility Policies: We develop, implement, and maintain policies to achieve accessibility and meet relevant requirements. Our policies are reviewed annually.
- Multi-Year Accessibility Plan: We have established, implemented, and maintained a multi-year accessibility plan to continually improve our digital accessibility.

## **Expertise and Testing**

- Expert Consultation: We utilise accessibility experts to evaluate and test our digital assets for WCAG 2.2 Level AA conformance. A written report is prepared to identify any barriers and provide recommendations for enhancement.
- Continuous Testing: We engage in automated/ manual testing to continually assess and improve the accessibility of our website and other digital assets.

# Compliance

Compliance: Our proactive efforts and genuine commitment to accessibility ensure that we meet and exceed digital accessibility requirements set forth by the European Accessibility Act (EAA) and other applicable European regulations and directives.
